Peaceful Valley Scout Ranch June 18, 2006 - June 24, 2006

This year the troop has decided to attend Peacefully Valley Scout Ranch in Elbert County, Colorado. The camp required that reservations be made by October 1, 2005. We complied and have reserved to two campsites for fifty (50) scouts and eight (8) adult leaders. Under this current situation we are guaranteed five (5) adult leaders at no charge. If we add one more scout, we will be given another free adult spot.

The issue before us tonight is when to begin collecting camp payments. Below is a list of the Denver Area Council's mandatory payment schedule based on our current reservation. The cost per scout is \$200.00. We can add additional scouts up to the March 6, 2005 date. After this date, only new additions to the troop can be added.

EAGLE SCOUT PROJECT REQUIREMENTS HANDOUT September 28, 2005

What Qualifies: An Eagle Scout service project must provide an opportunity for the Candidate to demonstrate the leadership skills he's learned in Scouting. BSA gives general recommendations (but not specifics about what will qualify for Eagle Scout Leadership Service Project) such as "assist a school, religious institution or his community", so the Candidate can demonstrate creativity and thought. If the Candidate is having difficulty thinking of a Project, he may wish to look at the previously cited reference materials for guidance. There is no minimum number of hours that must be spent on carrying out the project, but the amount of time spent must be sufficient to clearly demonstrate leadership skills. Note: It's recommended the Candidate keep a log of all the time spent conceiving of, completing and reporting on his project, all the people that helped and how much time everyone spent (individually) on all parts of the project. This log begins with the first contact he makes during the initial concept phase, through the time spent on the final report.

What does not qualify: Work involving council property or BSA activities is not acceptable for an Eagle Scout service project. The service project may not be performed for a business, be of a commercial nature, or is a fund-raiser. NOTE: Fund-raising is permitted only for securing materials or supplies needed to carry out the project. Routine labor, a job or service normally rendered, should not be considered.

- a) Beginning Balance \$15,496.09

5) Eagle Update

- a) Eagle Project Requirement Review: Mr. Zimmer provided a handout for the committee regarding what qualifies as an eagle project. An Eagle Scout service project must provide an opportunity for the eagle candidate to demonstrate the leadership skills he's learned in Scouting. The emphasis of the project is the demonstration of the skills and not so much what is built or completed. In addition, the project must be "in the community" and not on BSA property. (See note below)
- b) Michael D's Eagle proposal that was originally presented at the last month's meeting will be brought to a Troop meeting so he can make a formal presentation and move his project forward in a timely fashion.
